

Conditions of Entry

Entry to the Park is conditional to the full acceptance of all of the following conditions. Upon entry to the Park, guests accept unconditionally all of the following conditions.

Bookings

- Park Management reserves the right to adjust date and locations of forward bookings as it deems necessary.
- Minimum booking periods apply for the Peak Season.

Fees

- All outstanding accommodation fees are payable in full on arrival and cover the entire booked period.
- Prices are subject to change without notice, and are reviewed and adjusted at the start of each financial year.

Deposits/Refunds/Deferrals

- Deposits on accommodation and booking fees are non-refundable within four weeks of the expected check-in date or , in the case of Peak Season bookings, twelve weeks. When cancellations are made outside the non-refundable period, deposits will be returned, less an administration fee of \$10.
- Prepayment of the basic site fee is required for Easter and Christmas periods and is non-refundable within 7 days of the expected check-in date.
- Refunds are not given on premature or early check-outs under any circumstances.
- Deferrals may be made once only, covering a forward period of twelve months, on the condition they are made outside the non-refundable period. Deferrals cannot be made within the non-refundable period. Deposits are retained with a second deferral.

Arrivals

- All patrons are required to check in at the Park Office on arrival. If arriving after Office hours, please proceed to your site and call at the Office the following morning.
- Caravans must be parked at right angles on sites with the van's drawbar facing the road.

Visitors

- Site holders are responsible for the charges of overnight visitors on their site.

Duty of Care

- Breakages, damages etc must be reported to the Park Office. Reimbursement for any breakages damages, etc. is the responsibility of the guest completely.
- Sites and cabins are to be left in a neat and tidy condition on departure. Camping trenches are to be refilled where constructed.
- Please consider others and keep volume of televisions, radios, etc. at an acceptable limit at all times. Get togethers must end by 11pm. Unruly or antisocial behaviour will result in immediate expulsion. In this circumstance, fees paid in advance will not be refunded or returned.
- Individuals using the Park and the Park's facilities do so entirely at their own risk and consequence. Neither the management, lessee, employees, contractors or affiliates will accept any liability whatsoever for any claim made on behalf of persons or property against the Park or any of the aforementioned groups.

Pets

- Pets are not permitted in any of the cabins under any circumstances. Pets are permitted in the powered and unpowered section after consultation with the Park Management in the Off-Peak and Mid-Season only. Pets are not permitted within the Park over the Easter Long Weekend from Good Friday until Easter Tuesday, or from the 26th December until the 15th January.

Campfires

- Campfires may only be lit within a metal fire-safe container or a designated fire place and must conform to CFA policy. Campfires are not permitted on days of total fire ban OR on days that may be deemed unsuitable by the Park Management. Fire Bans will be advertised by the Park Management by 9:00am at the Park Office. Fire bins are available for hire at the Park Office. Full campfire regulations are available by request from the Park Office.
- Chainsaws are not permitted to be used within the Park.
- Only "domestic-sized" firewood may be brought into the Park. Larger logs may not be brought into the Park grounds.
